ii. The partner with whom a Union citizen lives in a *de facto* union, established under the law, or with whom the Union citizen has a permanent relationship, duly certified by the competent entity of the Member State where he/she resides;

iii. The direct descendant under the age of 21 or who is in charge of a Union citizen, as well as that of the spouse or partner within the meaning of the previous subparagraph;

iv. The direct ascendant that is in charge of a Union citizen, as well as that of the spouse or partner within the meaning of point (ii).
